# Operating Policy and Procedure 142

### **Sub-Organizations**

**SCOPE:** Applies to the Board of Directors of both corporations, all sub-organizations and webmaster. Guiding documents are IRS rulings for 501(c)7, bylaws and financial policies/procedures.

<u>PURPOSE:</u> Provides written guidelines to define and set criteria for the following suborganizations: Clubs, Departments, Activities and Events. It will guarantee scheduling and usage of the Betmar Acres Club, Inc. common grounds and facilities is for those suborganizations authorized to do so.

#### **POLICY:**

- 1. Any newly proposed sub-organization must be approved by the Board of Directors.
- 2. The Board of Directors will determine proper category based upon criteria.
- 3. Once approved, recognized sub-organization may:
  - a. Reserve facilities in accordance with Policy 140.
  - b. Advertise in the bulletin/calendar.
  - c. Make announcements via coffee news/Friday notes.
  - d. Post on the clubhouse bulletin boards.
  - e. Utilize the website Betmar.org for posting sub-organization information and events.
- 4. Sub-organizations are responsible for adhering to policies/procedures:
  - a. 114. Non-resident participation
  - b. 123 Club Financing Policy and Procedure
  - c. 138 Owners Financial Policy
  - d. 137 Acres Financial Policy

## **PROCEDURE:**

1. Any sub-organization Board of Directors/Points of Contact changes must be reported to Office Administrator, Secretary and the Webmaster.

- 2. Sub-organizations must annually review respective information displayed on the Betmar.org website. .
- 3. Clubs must review and update their bylaws at least every five (5) years or when applicable Betmar Owners, Inc. Bylaw changes occur.
- 4. Club bylaws cannot be in conflict with the Betmar Owners, Inc. bylaws.
